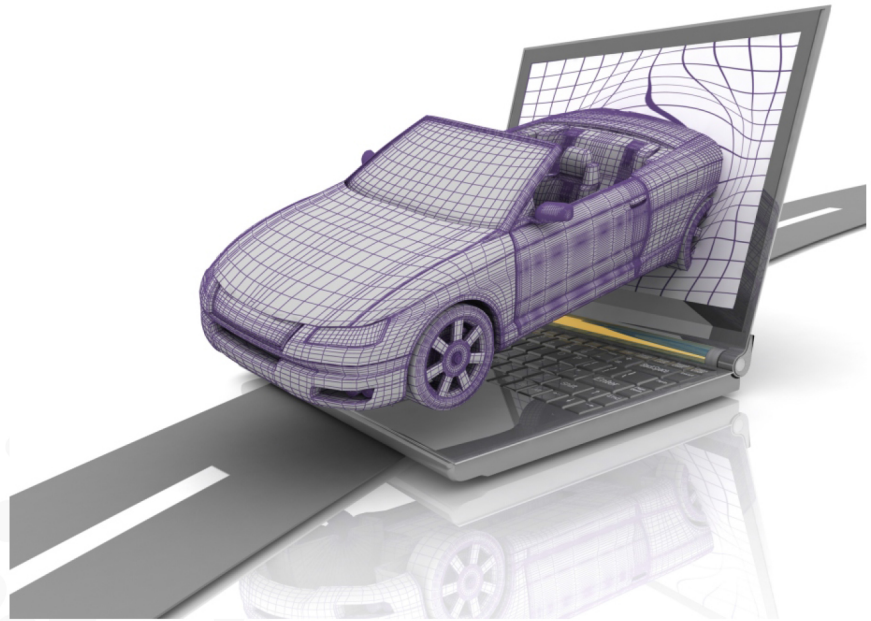

IATF 16949 Executive Overview

Seminar Content

The new Automotive Quality Management System requirements have been rebranded as IATF 16949:2016 (formerly ISO/TS 16949:2009). Omnex is offering a half-day executive briefing on the transition to IATF 16949:2016. This briefing highlights the intent and content of the key changes from the IATF 16949:2016 revision.
